General Circular

Reference unsigned letter of date October 28, 2007 (claimed to be signed by all the members) received by Association in the meeting called as per the notice of date 27/10/2007

The contents of the notice dated 27/10/2007 of the Association is produced ad verbatiem below under para (1 to 3).

- The Association received some verbal objections from the residents about holding of Diwali Mela. Subsequently, the Association had again met having considered the views of the representative members and re-confirmed to hold the Mela on Nov. 2, 2007.
- Accordingly, the residents were informed through notice/circular dated 25/10/2007. It was observed
 that inspite of this few residents still had reservations and approached few of our members of the
 Association.
- 3. On 26/10/2007 Mrs Shiela Prasad (D-505) along with others met the Association members to seek various clarifications which were hence forth clarified there itself. Mrs Shiela were kind enough to reconsider the trust put in the Association's decision by around 115 members by making contributions to hold the function on Nov.2,2007. Subsequently, the discussion ended with a note that Mrs Shiela would submit a letter duly signed by the representative members allowing the Association to hold the function on Nov. 2, 2007 which Mrs Shiela had verbally agreed to also. Mrs Shiela was also given the option to submit an objection letter, if any, duly signed by the representative members by evening of 27/10/2007. Since Association has not received any communication, Mrs Shiela was requested to kindly come for discussion along with the relevant letter on 28/10/2007 at 7.00 PM at C-204.
- 4. In the above letter (copy enclosed) the Association has been blamed of taking unitateral and dictatorial decisions. It may be mentioned here that all the decisions of this Associations were taken in the meeting of the Executive Body. This practice has been followed by the earlier Executive Bodies of CGERWA and the Executive Bodies of the RWAS elsewhere also. Hence this blame on the Association is totally uncalled for. The letter was received by the Security Guard Mr. Ram Raj Singh from the allottee of C-604 to be given to the Association.
- 5. In the above letter there is blame on the Association that gesture of the Association were not appreciated by a sizeable number of Association members. It may be recalled that decision of the Association for holding of Diwali Mela on Nov.2, 2007 and calling for contributions of Rs.100/- were well received /responded by 120 members (including those who have raised objections to the decisions of the Association). This itself constitute a sizeable proportion giving consent to the decision of the Association; hence, this blame on the Association not fitting properly.
- 6. In the letter it was desired that Association should call for AGM to discuss the financial position. It may be recalled that calling for AGM adds expenditure of Rs.7-8 thousand as per the past experience. As the election to new Executive is just few months away. It will not be proper to hold AGM to discuss financial position only.
- 7. Going by the spirit of the letter (though unsigned but claimed to be signed by all the members), Executive Body has sufficient reasons to quit. Accordingly majority of the members (including President, Gen Secretary, Treasurer, and members) of the Executive Body have resigned herewith. This note of resignation duly signed by members of Executive is given to Electoral Officer Mr. Kotabaghi at C-607 who has consented to be the electoral officer for the election of new Executive Body.
- All the cultural programmes involving expenditures are being cancelled herewith till the next elected body takes over. Contributions received from the members for holding Diwali Mela will be adjusted against the monthly subscription for the month of November 2007.

- 9. The election process has been initiated and will be completed shortly. The financial position along with other issues as desired in the above letter will be discussed in the AGM.
- 10. The existing Association will continue to hold the office and carry out the basic minimum activities (like looking after security arrangements, payment of utility bills etc) till new Executive takes over.
- 11. This note along with letter as mentioned above received by the Association is being circulated to all the members and displayed on notice board for information.
